

## **SPECIAL RULES FOR “CASH FEVER” COMPETITION**

These rules set out the special conditions and the practical details specific to the “Cash Fever” Competition. For all other matters, please refer to the “*General Competition Rules of the Company*”. These Rules form an integral part of the conditions applicable to the competition and are available on the website [www.CIRCUS.be](http://www.CIRCUS.be)<sup>1</sup>.

Participation in this competition constitutes full and unreserved acknowledgement and acceptance of these special rules and the General Competition Rules. Any claims or disputes subsequent to the player's participation on the elements of these will not be accepted.

### **A. Competition name:**

Cash Fever (hereinafter the “Competition”)

### **B. Organizer:**

CIRCUS BELGIUM S.A. with its head office at 4000 Liège, rue des Guillemins 129, registered under the business number CBE 0451.000.609.

### **C. Duration of the Competition**

From 01/02/2023 to 21/12/2023 for all the CIRCUS CASINO establishments. The event will take place within each establishment, every month during the period from February to December 2023.

### **D. Competition location:**

All the CIRCUS CASINO gaming halls, class II establishments.

### **E. Territorial limits:**

Belgian territories

### **F. Conditions for participation:**

- It is obligatory for the participant to be registered on the [www.CIRCUS.be](http://www.CIRCUS.be) website;
- Presence is obligatory within a CIRCUS CASINO establishment;
- The Competition participation form is to be fully and correctly completed (personal details, requested information, etc.) by the participant for every month during which the competition takes place (February to December 2023);
- Complete and solve the game on the participation form
- Take part in our game of skill and succeed

### **G. The running of the Competition:**

#### **1. Participation in the Competition:**

Participation in the Competition involves obligatory presence within one of the CIRCUS CASINO establishments. A single participation form will be authorized per person and per gaming hall for every month during which the Competition takes place.

The participant must:

- a. Fully and correctly complete the Competition participation form with the required personal information. A participation form must be completed for every month during which the participant wishes to take part in the Competition;

If all these conditions are fulfilled, the game form will be considered validated and valid in the CIRCUS CASINO establishment and for the month in which it was registered.

## 2. Attribution of participation tickets.

Following the validation of the participation form, the player will receive, from the first day of each month, per day of visit<sup>2</sup> and based on their CIRCUS CLUB<sup>3</sup> status, a proportional number of participation tickets. The tickets must be put into the box provided for this purpose within the CIRCUS CASINO establishment where they were handed out.

## 3. Final monthly draws:

Every month, following a schedule to be defined and close to the 3<sup>rd</sup> Thursday of each month, a draw will be organized on a national level and broadcast on our internal Circus TV screens.

During the draws, ten CIRCUS CASINO establishments will be selected by random draw from all the participating establishments. Then, each manager of the CIRCUS CASINO establishments selected will carry out a draw locally.

During this local draw in the gaming halls, the manager of the gaming hall will select five different people by drawing five participation tickets from the box in the establishment. The people corresponding to the numbers written on the participation tickets selected must make themselves known to the manager within two minutes. If one of the people is not present in the given time, a new draw will be done within the establishment to determine a new person and, therefore, to have the five people who will take part in the game of skill.

Once the five people have been selected, they will compete in a game of darts. Each person will throw five darts at a target (one try per dart) one after another, and the person who gets the highest total score after throwing the three darts will get the prize.

## 4. Allocation of prizes

A prize of a thousand euros (€1,000) paid directly in cash will be awarded to each winner in the ten CIRCUS CASINO establishments that were randomly drawn. The prizes will be attributed to the winners and collected directly in the CIRCUS CASINO establishment where the draw took place. Prizes cannot be returned or exchanged.

## **H. Personal data protection:**

The participants' personal data communicated to the Company as part of the Competition is processed by the Company for marketing purposes (marketing related to offering new games
