- Be at least 21 years old to be able to take part in the Contest.

- G. The running of the contest
 - 1. Participation in the Contest

During the promotion period, the participants can try to guess the exact value of the total selection of prizes visible on the page dedicated to the promotion.

Participants will submit their answers using the questionnaire provided on the dedicated page.

Each participant is allowed one attempt per day to submit a response.

The answers must be provided in euros, rounded to the nearest cent.

A contest day starts at 00:01 and ends at 23:59.

The value of the prizes is determined based on the sale price defined by the official vendors in Belgium.

The game is accessible for free and only to people who are registered on https://www.circus.be/en/casino and who reside in Belgium.

Any incorrect or fraudulent entries will automatically invalidate a player's participation.

1. Determining the winner(s) and attributing winnings

Every week, the participants who give the three closest answers will be the winners.
