

## **SPECIAL COMPETITION RULES [ONLINE SAFE]**

---

These rules set out the special conditions and the practical details specific to the Competition [ONLINE SAFE]. For all other matters, please refer to the General Competition Rules of the Company, which are attached and form an integral part hereof and are available at <https://circus.vip/concours>.

Participation in this competition constitutes full and unreserved acknowledgement and acceptance of these special rules and the General Competition Rules. No dispute will be accepted.

- A. Name of the competition: [ONLINE SAFE] (hereinafter the "Competition")
- B. Organizer: CIRCUS BELGIUM S.A. Rue Saint Exupéry 17, boîte 13 4460 Grâce-Hollogne (hereinafter the "Company")
- C. Duration of the competition: [From 25/05/2021 at 12:00 to 08/06/2021 at 23:59]
- D. Location of the competition: Circus Belgium social media (on the <https://www.facebook.com/CircusBelgium> Facebook page)
- E. Territorial limits: Belgian territories
- F. Conditions of participation: the participant must be at least 21 years old and live in Belgium
- G. The running of the Competition  
Every day, the participant should find a 3-digit code with the help of the clues on the local Circus Casino Facebook pages as well as on the Grand Casino de Namur page. Each participant will receive a unique code that they should show in the gaming hall once it has reopened to get an extra chance to try and open the safe in the Circus Casino gaming hall of their choice.

### *1. Participation in the Competition as it is*

Participation in the Competition takes place exclusively on the <https://www.facebook.com/CircusBelgium> Facebook page

Participation should have taken place before 23:59 that day as a competition is organized each day.

The Competition will take place as follows:

- The participant should submit their entry a maximum of once per day on the Circus Belgium Facebook page by contacting the page via direct message. The message should include:
  - o The participant's username for the Circus.be website;
  - o Their guess of the day's 3-digit code.

Multiple entries will automatically invalidate a player's participation.

## 2. Determining a winner(s) and attributing winnings

All participants will receive a ticket for the offline safe game that will take place in the Circus Casino gaming halls when they reopen from 09/06/2021. A winner who gave the right combination and opened the safe will be selected each day. If there is a tie, a draw will be organized for the participants who have the right combination. Each day, the winner will get 1,500 coins credited directly to their Circus.be player account, subject to the player providing their correct username. The coins will be credited to the player's account at the latest 72 hours after they took part.

### H. Terms of notification of the winner and withdrawal of prize

The winner will be informed they have won by direct message via the Circus Belgium Facebook Page in response to the participant's entry.

In addition, each participant will receive a ticket by direct message in the form of a single-use code to provide in the Circus Casino gaming hall of their choice at the reopening. This ticket will allow them to have an extra chance to open the safe in the gaming hall of their choice.

### A. Other/Specific limits

Participants can use their extra tickets in the Circus Casino gaming hall of their choice as long as the safe has not already been opened.

Any disagreement regarding the choice of winners will not be accepted.

### B. Personal data protection
