- D. <u>Competition location</u>: circus.be
- E. <u>Territorial limits</u>: Belgian territories.
- F. Conditions for participation:
- Must be 21 years of age or older to enter the Competition.
- Registration and creation of a player account at circus.be
- G. <u>The running of the Competition</u>

1. The running of the Competition:

During the promotion period, each day, participants can try to answer 2 knowledge questions as well as a tie-breaker question within a limited time.

Participants will submit their answers using the questionnaire provided on the dedicated page.

Each player is allowed one attempt for the whole duration of the competition to submit a response.

The game is accessible for free and only to people who are registered on https://www.circus.be/fr/casino and who reside in Belgium.

Any incorrect or fraudulent entries will automatically invalidate a player's participation.

2. Determining a winner(s) and attributing prizes:

The participant who correctly answers the knowledge questions and gets the closest answer to the tie-breaker question will be selected as the winner.

The winner will win a safari trip for 2 people in Africa, in the form of a €8,000 voucher from the travel agency "Blue Sky Travel". Details will be communicated to the winner within 72 hours.

If there is a tie, the player who gave their answer earlier in the promotion will be the winner.

The winner will be contacted by email. If they don't react within 3 months, the prize will be canceled.

The Competition prizes are only awarded to participants who have a Circus account that is valid, trusted (copy of the identity card sent and validated by Circus) and open before the closing date of the Competition.

Non-exchangeable reward.

*To be eligible for the reward, the player must be considered active on Circus.be.

Active player: A player who has been active on the circus.be platform for the last three months.

- Activity: Player who has earned at least 1 point in the last 7 days.

- Point: Unit measuring a player's activity. In online casino games, you receive 1 Point as soon as you bet :
