A. Name of the contest: [Champions League - Quarterfinals - first leg] (hereinafter the "Contest")

C. Duration of the competition: from 06/04/25 to 08/04/25 at 20:59

D. Contest location: Circus-sport.be

E. Territorial limits: Belgian territories

F. The running of the Contest

#### **1. Participation in the Contest**

Participation in the Contest is carried out exclusively by taking part in the "Champions League - Quarterfinals - first leg" game at Circus-sport.be.

The game is accessible for free and only to people who are registered on [www.circus-sport.be](http://www.circus-sport.be) and who reside in Belgium.

As part of the Champions League - Quarterfinals - first leg Contest, Circus Sport players can answer two knowledge questions and predict the final bracket of the Champions League. Participants must choose the winner of each duel until the final, where a single winner will be crowned.

Any incorrect or fraudulent entries will automatically invalidate a player's participation.

## 2. Determining a winner(s) and attributing winnings

Players who correctly answer both knowledge questions and who manage to predict the winners of all the matches until the final will evenly share the prize pool of €2,500 after the end of the Champions League final on 31/05/2025.

*\*To be eligible, the player must be considered active in sports bets on [www.circus-sport.be](http://www.circus-sport.be). (Player with Activity on the [www.circus-sport.be](http://www.circus-sport.be) platform during the last seven days). Activity: The fact that the Player has won at least one Point over the last month (see rules at [www.circus-sport.be](http://www.circus-sport.be)).
